TOOLS

2 Large Adjustable Crescent Wrenches (OPW advises against using channel locks to install.)

STEP 1

INSTALLING THE OPW 66FL FLOW LIMITER (SEE FIGURE 1) The OPW 66FL is designed to be installed between the whip hose and the breakaway. Before beginning installation, drain the entire hose and nozzle assembly.

STEP 2

REMOVE WHIP HOSE Using the crescent wrench, remove the whip hose from the outlet casting. Then, using both crescent wrenches, break the connection between the whip hose and the breakaway.


STEP 3

THREAD OPW 66FL INTO BREAKAWAY Make sure the orientation of the OPW 66FL is correct. The female inlet should be pointing up, the male outlet should point down. The flow arrow should be pointing down. Thread the 66 FL into the breakaway and tighten using the two crescent wrenches. **CAUTION:** Do not wrench across the breakaway.

STEP 4

Thread the whip hose into the OPW 66FL and tighten using the two crescent wrenches. Reinstall the whip hose into the dispenser outlet casting using one of the crescent wrenches.

Bleed the air out of the hose and nozzle by activating the dispenser hose point and opening the nozzle lever. Dispense at least 2 gallons of gas.
