Replacements for TCI 1-1/2" Components

RRD-3915TC	Used with TCI entry boot EF-5039 or CB/FB-3950
DPC-2150	1-1/2" Double Wall Stainless Steel Coupling
RRD-3515TC	1-1/2" Replacement donuts to be used in conjunction with EF-5036 Entry Boot (pre-1992).

Replacements for TCI 2" Components

RRD-3920TC	Used with TCI entry boot EF-5039 or CB/FB-3950
DPC-2200	2" Stainless Steel Double Wall Coupling
RRD-3520TC	2" Replacement donuts to be used in conjunction with EF-5036 Entry Boot (pre-1992).

RRD-3915TC (for our 1-1/2" FlexWorks pipe). RRD-3920TC (for our 2" FlexWorks pipe). Used to replace the Total Containment donut, TD2515 and TD2520. This donut meets the same O.D. and thickness of the TD-2515 and TD2520.

The I.D. of the RRD-3915TC is made to accommodate our 1-1/2" DW FlexWorks and the I.D. of the RRD-3920 is made to accommodate our 2" FlexWorks. Typically these will be used if the Total Containment boot is in good condition, but the donut needs to be replaced due to damage. Note: Reference OPW FCS Installation Manuals for complete instructions.
